Hermanto Dardak is the Head of Regional Infrastructure Development Agency and was the previous Vice Minister of the Indonesian Ministry of Public Works, in a career that spans some 30 years in the Indonesian civil service. Prior to his appointment in 2010, he was Director General of Highways at the ministry and before that, Director General of Spatial Planning. From 2003 to 2005, Dr. Dardak served as Expert to the Minister on Autonomy and Synergy in Regional Development at the Ministry of Human Settlement and Regional Infrastructure. He is also a former Head of the Center of Policy Studies and Head of the Bureau of Planning and Overseas Cooperation.

Dr. Dardak earned a Masters in Civil Engineering from the University of New South Wales in 1985 and a PhD in Economic Transportation from the same university in 1990.

Andre Permana is Senior Vice President of Risk and Compliance (RAC) division in Indonesia Infrastructure Guarantee Fund (IIGF), a state-owned enterprise providing infrastructure guarantee to PPP projects in Indonesia. While he manages the division as central risk management function in IIGF from his inception up to now, he also handled guarantee risk monitoring and claim management functions for almost 2 years and assists in enhancing the risk underwriting capacity, especially for a 2x1000MW coal-fired power plant and a 1050l/s water supply project. He joined IIGF since mid 2010 after completing his PhD study at School of Civil and Environmental Engineering, Nanyang Technological University, Singapore. His research topic is the assessment of government contingent liabilities from political risk in public-private-partnered infrastructure projects in Indonesia.

They include core corporate functions such as human resources, finance, legal issues, public affairs and outreach programmes.

As a seasoned management and international relations expert, DSG Mochtan has held top positions in various international organizations. Immediately before joining ASEAN, he directed the Japan ASEAN Integration Fund (JAIF) Management Team, which managed over US\$500 million grants from the

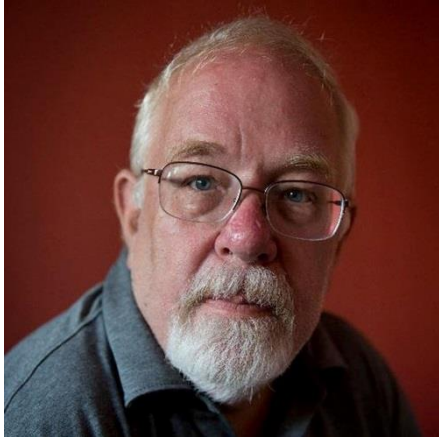
### **Benjamin Cass**
